SWEDISH ACADEMIC BOOKS

Is private funding of science a threat to finding the truth? A recent study published by the Swedish National Agency for Higher Education shows that Sweden is unique with regard to the proportion of private funding of science at the universities. Among the OECD countries only Great Britain has a higher share of private funding than Sweden. Since a couple of years, private funding accounts for around 15 per cent of financing of research and doctoral studies – a level comparable to the U.S. and surpassed only by a few other EU countries.

There is a fear that increasing dependence on private funding will have a negative effect on the diversity as well as the search for truth in today's Swedish scientific community. As a reply to this critique, former vice-chancellor at Lund University Göran Bexell, emphasises that academic freedom must be the vital nerve for a successful university. A balance between research chosen by the free will of scholars together with increasing diversity and some external financing should be every university's essential mission.



This study presents the results of a small but intensive surface survey conducted on the Mastos Hill in the Berbati Valley in 1999. While remains from the Early and Late Helladic period were known from previous excavations on its southern and eastern slopes, this is the first



analysis of the entire hill. It includes a digital documentation of the local topography as well as an account of the archaeological remains retrieved in the field. The study fills a gap in different data sets and results gained through old excavations and the extensive 1988–1990 Berbati-Limnes survey.



This is the third and final volume in a series of catalogues raisonnés dealing with Dutch and Flemish paintings in the Nationalmuseum.

This volume covers famous painters like Anthonis van Dyck, Peter Paul Rubens, Jan Brueghel I, Jacob Jordaens, Frans Snyders and Jan Fyt,

but also less known artists.

The research conducted into the collections covers not only provenance, iconography and stylistic analysis but also documents all 239 paintings from a material and technical point of view. This includes pigment analyses, dendrochronological examination and an examination of the paintings with the aid of UV, X-radiography and infrared reflectography. The findings have in some cases offered new information and a number of paintings have as a result been given new attributions and dates. The authors of the catalogue are Professor Görel Cavalli-Björkman, PhD Carina Fryklund and Director of Research and Associate Professor Karin Sidén in collaboration with Lena Dahlén and Stefan Ohlsson in the museum's conservation studio and Professor Peter Klein in Hamburg for the dendrochronological analyses.

The question I address in the thesis is how cooperation in social dilemma situations and compliance with environmental regulations are determined by legal enforcement, intrinsic motivations and culture. In light of this, the thesis consists of five independent chapters.

Chapter 1 analyzes the effects of the interaction between technology adoption and incomplete enforcement on the extent of violations and the rate of abatement technology adoption. In Chapter 2, I study the effects of targeted monitoring strategies on the adoption of a new abatement technology and, consequently, on the aggregate emissions level when firms are regulated with uniform taxes. In Chapter 3 we propose an alternative theoretical model that predicts that the extent of violation is sensitive to such combinations, i.e., these two probabilities are not perfect substitutes. Chapter 4 investigates whether disclosure crowds out

pro-social behavior using a public goods experiment. In Chapter 5 we keep cross- and within-country characteristics constant.



This dissertation examines the labor market outcomes of a population of natives and immigrants in Sweden from 1968 and until 2001. Previous research has consistently pointed to the importance of an individual's country of origin, without being able to fully explain why this is the case. The standard approach is to use the country of origin as a way to measure everything occurring prior to migration, including linguistic and cultural differences from the destination country. Using unique information on an immigrant's experience prior to migration, this thesis differentiates some of the mechanisms which are usually merged into the country of origin effect. Including measurements of language skills, labor market experience, formal education and early-life conditions, the thesis empirically estimates the magnitude of their effects on immigrants' post-migration labor market outcomes. The thesis furthermore assumes a full career perspective and examines the influence of such pre-migration factors on the immigrants' entire labor market career in Sweden.



This study explores the basic social conditions for high-quality university research, and focuses on research in science and technology in Sweden. Swedish research policy has adopted more of a market perspective on academic research and its role in society. This has meant the promotion of competition between researchers, increased focus on efficiency at universities, and attempts to make academia harmonize more with industry and other actors. How do such policies affect the variety of perspectives within the academic system? How do they affect the positions and identities of individual academics? These issues are discussed through the concept of "relational tensions". Relational tensions refer to social strains arising when interacting actors have different perspectives. Relational tensions can stimulate creativity, but may also cause unproductive conflicts. The discussion is underpinned by interviews with university researchers and a case study of Uppsala BIO-X, a program to commercialize university research in biotechnology. Typical cases of relational tensions are identified. These concern both interpersonal relations and differences between organized science and industry.

This publication highlights other important aspects of power, while also relating them to the armed conflict. The four chapters make an in-depth investigation of power relations historically as well as in contemporary Sri Lanka. They analyse the interlinkages between power dynamics at the global, national and local level (Orjuela), the power struggles involved in processes of political reform (Uyangoda), the ways in which power in Sri Lankan society is gendered (Kottegoda), and the intersection of politics and the market economy (Bastian).

Raoul Wallenberg is a genuine hero of the Holocaust, revered and honoured by millions worldwide for his humanitarian achievements in Budapest in 1944. During his often dramatic six months in that tragic city, Wallenberg and his diplomatic colleagues saved and assisted many thousands of Jews. Though

much written about, existing publications about Wallenberg have been hagiographic in nature rather than historical, characterized by inaccuracies, exaggerations, and a lack of historical context.

Paul A. Levine has studied Wallenberg and Swedish diplomacy during the Holocaust for twenty years. Using contemporary Swedish diplomatic documents never before studied, Levine places Wallenberg in an accurate historical context, providing an almost daily picture of his activities, including his essential negotiations with Hungarian officials, German and Hungarian Nazis, and other neutral diplomats. Through careful analysis of Wallenberg's own personal and diplomatic correspondence, this study provides a richer and more nuanced picture of this fascinating but generally misunderstood figure. Though not a biography, Wallenberg's up-bringing is explored, with the motives and goals for his mission analyzed. This study replaces the one- dimensional caricature which has long dominated the public's view of Wallenberg with a more complicated individual who made history during the Holocaust.

Intractable conflicts are by definition difficult to resolve. This study ventures into the identity dynamics of those conflicts and argues that those identity aspects must be addressed in order to locate constituencies for change. Through the employment o theories of conflict transforma-

tion, identity and narrative, the dissertation forwards thoughts regarding the importance of inside actors formulating narratives of recognition of the opponent in conflict. Through the recognition of deeply held identity aspects, such as the others' narratives of history, conflict relations might develop into new and more peaceful forms. This study uses the Israeli debates over New History as a critical case in order to develop the concept of thick recognition. Through elaborations on the case, the processes by which thick recignition are introduced and circumstances which make them either take root or wane are explored. The study identifies inside actors, here understood as memory-agents forwarding different view of history, as crucial in the process of transforming conflictual relations. The disseratation hence challenges the traditional focus on third party interventions and elite negotations within conflict teory, and suggests that those have little to offer as long as profound identity dynamics in conflicts, as well as interactions among their inside actors, are disregarded.

In the present study the possibility of an early appearance of the god Dionysos and his sphere in archaic Rome, in the decades around 500 BC, will be examined. In early scholarship, rooted in the 19th century, the phenomenon of Dionysian ecstatic rites, cults, and satyr-plays in Roman society was denied. According to that view and the subsequent tradition in religious studies, such cultic activities were not present in Rome. Furthermore, due to Christian presuppositions, religion could scarcely be connected with sexual activities and bawdy behaviour, and as this is one fundamental quality in Dionysian cultic activities, it was reason enough for neglect and rejection of the thought of Dionysian cult as religion proper, on the whole. These preconceptions have long prevailed and formed

the foundation for research in Roman religious studies. Scholars in various disciplines now challenge these ideas.
