SWEDISH ACADEMIC BOOKS

"AT LAST", RETIRED LECTURER Staffan Bergsten from Uppsala University exclaimed when The Nobel Prize in Literature 2011 was awarded to the Swedish poet Tomas Tranströmer. Together with Tranströmer Bergsten started the university course "Creative Swedish" in the 1970's. Today, researchers on Tomas Tranströmer's poetry are represented at several of the Swedish universities.

At Stockholm University, Torbjörn Schmidt is currently working on his dissertation. Schmidt has previously published the book "Air Mail", a correspondence between Tranströmer and the American poet Robert Bly. Tranströmer was introduced in the US by Bly in the 1960's and since then, international interest in his poetry has grown. Translated into more than sixty languages, Tranströmer is one of the most translated and read post World War II poets.

The timing of the appointment is believed to be a result of huge international pressure. When the disciples of Tranströmer; Derek Walcott, Seamus Heaney and Joseph Brodsky were awarded with the prize, they wondered why they received it and not the master, says Tranströmer expert Niklas Schiöler at Lund University.

As a consequence of the Tranströmer fever, a new course has started at Umeå University: "The Nobel Prize in Literature".

This dissertation is concerned with the relationship between accounting earnings and stock prices. It consists of three empirical papers, all using a sample of firms listed on the Stockholm Stock Exchange (1990-2008). The first paper documents the existence of a drift in stock prices

subsequent to quarterly earnings announcements. Two interesting empirical observations are that the drift is only significant for longer holding periods and that the drift on the short position, i.e. after bad earnings news, is negligible. The lack of downward drift on the short position is interpreted as an indication of the post-earnings announcement drift, at least partly, being explained by investors demanding a compensation for a risk factor that is omitted in the test design. 

It is argued that this uncertainty might be due to GAAP earnings encompassing items that prior research has shown more likely to be manipulated and/or to contain estimation error. The positive association between information risk and expected return is further investigated in the third paper, where information risk is measured by earnings quality metrics. Using a new approach to estimate the implied cost of capital, it is found that Swedish investors demand a higher expected return for firms with poor earnings quality, i.e. firms associated with higher information risk.

Drawing on participant observations, group and individual interviews with students and teachers, and questionnaire data, the dissertation questions the hitherto dominant understanding of bullying as proactively aggressive actions and instead shifts the focus away from individual behaviour and actions towards a more in-depth consideration of power relations and the role bullying plays within the institutional context of schooling. Rather than understanding power as something which is held by some individuals who abuse their power when bullying others, the dissertation adopts a Foucauldian approach to power, wherein power is not held but is rather exercised in strategic situations. In doing so, the dissertation illustrates how schools provide not only the setting for school bullying but also the disciplinary framework within which school bullying gains currency.


