THE ALARM CLOCKS started ringing when the PISA 2012 report was released in the end of 2013 and the discouraging Swedish results were revealed. The Programme for International Student Assessment (PISA), which aims to evaluate education systems worldwide, placed Sweden last among the Nordic countries and the Swedish 15-year-old students were ranked somewhere below the average in the study, resulting in a lively debate and strong criticism concerning the status of the Swedish school system.

In February, British Times Higher Education released their rankings of world class universities, where internationally prestigious Swedish universities had lost their placements from previous years of the same survey.

Maybe the focus on the current problems in the Swedish educational system was sharpened even more in the beginning of April, when members of The Royal Swedish Academy of Sciences published a debate article discussing the bad working conditions for elite scientists as a serious threat to Sweden's position as a top science nation internationally. The debate regarding the school system and conditions for highter education have indeed been vivid during the whole year.

The uncomfortable wake up-call will hopefully be followed by a reverse of the trend. In this newsletter are at least presented some new publications made by distinguished Swedish scholars and experts!

Christian Icelandic literature from the Middle Ages, but a growing body of material culture from pagan Scandinavia has recently started to have an impact on current research.

Moving to a new place is a major life event that often includes leaving a job, friends, and family

behind. The decision to move or not is even more complex for couples than for individuals because two jobs and two social networks must be taken into account. Considerable research has demonstrated that couples' moves are driven more by the man's than the woman's career and that men are more likely than women to gain economically from moving. Such patterns exist even in such relatively egalitarian countries as Sweden.

In her doctoral thesis, Maria Brandén examines gendered migration patterns, with a particular focus on the role of occupational sex differences. Although social media were initially characterised as non-commercial in nature, firms have started to manage interactions within these digital landscapes. From initially being characterised by its social base, this development implies that social media have become increasingly commercialised.

The imposition of customs duties and other trade restricting measures are covered by certain fundamental general principles, such as the non-discrimination principle which is a main principle of WTO law. The principle ensures that WTO Members should not discriminate against

Members may conclude Regional Trade Agreements (RTAs) which further liberalise trade between the parties. Under certain conditions they are also allowed to apply trade defence measures, such as safeguard measures, which are meant to be used in emergency cases only. Study I examines the associations between age, earnings, a student financial aid reform, and female students' first, second and third birth risks. Study II takes a gender perspective and compares the influence of mothers' and fathers' enrolment and earnings on parental couples' propensities to have a second or a third child. In both these studies the analyses are performed using longitudinal register data. Study III explores male and female students' childbearing intentions, and the motivations behind them, through individual in-depth interviews with childless students. Several findings point towards the significance of economic factors.
